76-Week Limited Workmanship Warranty



Every fence we install is backed by 76 FENCE Tampa for 76 weeks (about 17½ months) against defects in our installation and assembly. If it's our workmanship, we'll make it right.

Covers Our Workmanship

Defects in our installation and assembly. If it's our workmanship, we'll make it right.

76 Weeks of Coverage

Coverage runs 76 weeks from your installation completion date, as recorded in our records.

No Charge to You

If an issue is covered, we repair or correct the workmanship at no cost to you.

What's Covered

Defects resulting directly from our workmanship or installation, such as:

- ✓ Posts that were improperly set, aligned, or installed
- ✓ Panels, rails, pickets, and fence fabric that were improperly assembled or attached
- ✓ Gates that were improperly hung, including hinges and latches we installed
- ✓ Fasteners and other components installed by 76 FENCE Tampa

What's Not Covered

Damage or changes resulting from:

- ✗ Normal wear and tear
- ✗ Storms, hurricanes, high winds, flooding, lightning, or other weather events
- ✗ Soil settlement, erosion, ground movement, or drainage conditions
- ✗ Trees, roots, vegetation, animals, insects, vehicles, lawn equipment, or accidents
- ✗ Improper maintenance or misuse
- ✗ Alterations, repairs, adjustments, or modifications by anyone other than 76 FENCE Tampa
- ✗ Material conditions such as fading, rust, warping, cracking, or splitting (see manufacturer warranty)

Coverage applies to projects paid in full and runs from your recorded installation completion date. Material and product issues may be covered separately by the product manufacturer's warranty, where applicable.

76 FENCE Tampa — 76-Week Limited Workmanship Warranty

Coverage Period

76 FENCE Tampa warrants the workmanship and assembly of your fence installation for 76 weeks from the installation completion date, as recorded in 76 FENCE Tampa's records.

Eligibility

This warranty is conditioned on payment in full of the contract price for the installation. 76 FENCE Tampa is not obligated to perform warranty service on any project with an outstanding balance. The warranty period begins on the installation completion date regardless of when payment is received, and is not extended by any delay in payment.

What Is Covered

This warranty covers defects resulting directly from the workmanship or installation performed by 76 FENCE Tampa. Covered workmanship may include improper installation or assembly of posts, panels, rails, pickets, fence fabric, gates, hinges, latches, fasteners, and other components installed by 76 FENCE Tampa.

Our Remedy

If a covered workmanship defect is identified during the warranty period, 76 FENCE Tampa will inspect the affected area and, if determined to be covered by this warranty, repair or correct the workmanship at no charge to the customer.

Material & Product Warranties

This warranty applies only to workmanship and installation performed by 76 FENCE Tampa. Product defects, deterioration, fading, discoloration, corrosion, rust, warping, cracking, splitting, shrinking, expansion, or other material-related conditions are not covered by the 76 FENCE Tampa workmanship warranty. Such issues may be covered separately by the product manufacturer's warranty, where applicable.

Exclusions

This warranty does not cover damage or changes resulting from normal wear and tear; storms, hurricanes, high winds, flooding, lightning, or other weather events; soil settlement, erosion, ground movement, or drainage conditions; trees, roots, vegetation, animals, insects, vehicles, lawn equipment, or accidents; improper maintenance or misuse; or alterations, repairs, adjustments, or modifications performed by anyone other than 76 FENCE Tampa.

Scope

This warranty applies to the original installation performed by 76 FENCE Tampa at the original installation property and is limited to correcting covered workmanship defects.

Requesting Warranty Service

To request warranty service, contact 76 FENCE Tampa and provide the installation address and a description or photographs of the issue. 76 FENCE Tampa will evaluate the condition to determine whether it is covered under this workmanship warranty.
